

# TALBOT COUNTY, MARYLAND

County Council MINUTES February 25, 2025

Present – President Chuck Callahan, Vice President Pete Lesher, Keasha N. Haythe, Lynn L. Mielke, Dave Stepp, County Manager Clay Stamp, and County Attorney, Patrick Thomas.

- Agenda Mr. Callahan requested and received unanimous consent for approval of the Agenda for Tuesday, February 25, 2025.
- II. <u>Minutes</u> Mr. Callahan requested and received unanimous consent for approval of the Minutes of Tuesday, January 14, 2025, and Tuesday, January 28, 2025.
- III. <u>Disbursements</u> Mr. Callahan requested and received unanimous consent for approval of the Disbursements of Tuesday, February 4, 2025, Tuesday, February 11, 2025, Tuesday, February 18, 2025, and Tuesday, February 25, 2025.
- IV. Council Discussion with Trappe Town Attorney Lyndsey Ryan Regarding Allegations Involving Paris Foods' Municipal Sewer Connection – Lyndsey Ryan, Attorney for the Town of Trappe, and Brian Schmidt, President, Trappe Town Council, briefed the Council on the process and timeframe by which Paris Foods, a long-standing business in the town of Trappe, came to be connected to the Town of Trappe wastewater treatment plant. Ms. Ryan stated that Paris Foods approached the Town of Trappe in January 2021 to discuss the possibility of connecting to the Town's wastewater treatment plant as well as other options for providing sewer service to the property. She stated that at the time of the request, Paris Foods had a discharge permit from the Maryland Department of the Environment (MDE) for their own septic system which was due to be renewed in 2022. She stated that following the Town Engineer's review of data relating to the discharge from Paris Foods, it was determined that the discharge was of a level and magnitude capable of being treated by the Town's wastewater treatment plant. She stated that the MDE permit for the force main showing the connection of Paris Foods to the Town of Trappe wastewater treatment plant was made in accordance with the maps outlined in Resolution No. 281, as amended and approved by the Council in August 2020, which, in the Town's opinion, showed the Paris Foods property as "S-1". She stated that in August 2021, the Town entered into an agreement to provide 16 equivalent dwelling units (EDUs) to Paris Foods for connection to the Town's wastewater treatment plant. Ms. Ryan stated that it has been brought to the Town's attention that following corrective measures to Resolution No. 281, the Paris Foods property is shown as "unprogrammed". As such, the Town has submitted an application to amend the County's Comprehensive Water and Sewer Plan to reclassify the subject property to "S-1". Council discussion ensued with Ms. Ryan and Mr. Schmidt regarding various facets related to the connection of Paris Foods to the Town's wastewater treatment plant, including the timeframe between learning of the connection of the "unprogrammed" property and notification to the County, any MDE permit violations since connection of Paris Foods to the wastewater treatment plant and the process moving forward in order to avoid connection inconsistencies from happening in the future.
- V. <u>Presentation of Certificate of Recognition to Jeremy Hillyard, Talbot County Public Schools</u>

which spoke of the energy, passion and commitment Jeremy Hillyard devotes to the students at Easton High School, both in the classroom and in the community to help ensure their success in the classroom and in life, and his having been named as Talbot County Public Schools Teacher of the Year for 2024-2025. Mr. Hillyard stated that he has taught at Easton High School for 15 years where he teaches Spanish and Math. Council members congratulated Mr. Hillyard on having been named Teacher of the Year and for his devotion to the students at Easton High School. Ms. Haythe presented the Certificate of Recognition to Mr. Hillyard.

VI. Presentation of Certificate of Recognition to Rosario Steele, Talbot County Public Schools Support Staff of the Year for 2024-2025 – The Clerk read a certificate of recognition into the record which spoke of the welcoming manner, patience and understanding Rosario Steele provides for the needs of students at Easton High School, particularly ESOL (English for Speakers of Other Languages) as they navigate a new country. Ms. Steele serves as translator and tutor for ESOL students in their English and Math classes to help ensure the students are on par with other students in their classrooms, often using her own time to learn material in science and language arts classes in order to be able to provide assistance to students in those classes. Ms. Steele, who has been an ESOL assistant at Easton High School for seven years, was named Talbot County Public Schools Support Staff of the Year for 2024-2025. Upon motion by Mr. Stepp, seconded by Ms. Haythe, the Council approved the certificate of recognition by voting 5 – 0 as follows:

Council members congratulated Ms. Steele on having been named Support Staff of the Year for her devotion to the students at Easton High School. Mr. Lesher presented the Certificate of Recognition to Ms. Steele.

VII. Presentation of Certificate of Recognition to Water's Edge Museum of Oxford – The Clerk read a certificate of recognition into the record which spoke of the founding of the Water's Edge Museum in Oxford in 2021 which uses art as a means to showcase the rich cultural history of the Black Americans of the Eastern Shore, considered by some to be the Founding Black Families of America who lived, worked the water, tilled the soil, served their country, worshipped and established communities which continue to thrive into the present. The Museum's display of artifacts and its pictorial history serve as an example for young people to connect with their heritage by depicting a people who, throughout the centuries, have survived, despite the obstacles and hardships they faced, and whose stories are often untold or undervalued. Upon motion by Mr. Stepp, seconded by Ms. Haythe, the Council approved the certificate of recognition by voting 5 – 0 as follows:

Kay Brown, Assistant Director, Water's Edge Museum, briefed the Council on a current project of the Museum to bring the Middle Passageway signage to Oxford for placement in its correct setting, from the water's edge to the docking area. Council commended Ms. Brown and the Museum for highlighting the historic diversity of Talbot County.

Ms. Mielke presented the Certificate of Recognition to Ms. Brown who accepted on behalf of Water's Edge Museum.

VIII. Request from Chesapeake College for Use of Fund Balance for Award of Contract to Consultant for 10-Year Facilities Master Plan - Clifford P. Coppersmith, Ph. D., President, Chesapeake College; Karen Smith, Vice President for Administrative Services, Chesapeake College – Dr. Coppersmith briefed the Council on the request by Chesapeake College to utilize its Fund Balance in a sum not to exceed \$167,500 to hire the consultant firm, Design Collective, to complete the facilities master planning process for Chesapeake College. He stated that, if approved, the funding will be combined with \$75,000 of funding previously allocated for an athletic complex planning study in the M&R Athletics Master Planning Budget; total cost for the consultant is \$242,500; use of Fund Balance requires approval of a majority of the participating counties. Council discussion ensued with Dr. Coppersmith and Ms. Smith. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved use of Fund Balance as outlined by voting 5 – 0 as follows:

## IX. Introduction of Administrative Resolutions:

An ADMINISTRATIVE RESOLUTION ADOPTING AND APPROVING A GENERAL FUND RESERVE POLICY FOR TALBOT COUNTY, MARYLAND was read into the record by the Clerk and brought forward for introduction. Martha Sparks, Finance Director, stated that the purpose of a Fund Balance is to provide financial resilience to mitigate the impacts of unanticipated revenue shortfalls and/or unexpected expenditures. She stated that historically, Talbot County has budgeted very conservatively by underestimating revenues and overestimating expenditures and thus has been able to maintain a Fund Balance although the County does not currently have a formal reserve policy. She stated that maintaining and adhering to a reserve policy is a best practice recognized by the Government Finance Officers Association (GFOA) and is also a factor by which rating agencies determine an entity's creditworthiness. She stated that having a formal reserve policy also enables the County to obtain lower interest rates on borrowed funds. Ms. Sparks outlined the process by which the proposed policy was developed in conjunction with the County's financial advisor, Davenport & Company, and reviewed by the County's bond counsel. Council discussion ensued with Ms. Sparks. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved the administrative resolution by voting 5 – 0 as follows:

An ADMINISTRATIVE RESOLUTION AMENDING CERTAIN PROVISIONS REGARDING CITIZEN REPRESENTATIVES ON THE BICYCLE AND PEDESTRIAN ADVISORY COMMITTEE was read into the record by the Clerk and brought forward for introduction. Patrick Thomas, County Attorney, stated that that the administrative resolution had been drafted at the request of Mr. Lesher in order to provide the Council with more flexibility in appointing individuals to the Committee and to make sure that all areas of the county are represented. Mr. Lesher stated that the administrative resolution increases the number of citizen representatives from seven (7) up to eleven (11). Upon motion by Mr. Lesher, seconded by Ms. Mielke, the Council approved the administrative resolution by voting 5-0 as follows:

An ADMINISTRATIVE RESOLUTION REPEALING ADMINISTRATIVE RESOLUTIONS OF JUNE 23, 2020, AND JULY 14, 2020, REGARDING DIVERSITY TRAINING AND DEVELOPMENT OF A TALBOT COUNTY DIVERSITY STATEMENT, RESPECTIVELY was read into the record by the Clerk and brought forward for introduction. Prior to introduction, Mr. Stepp stated that he is proposing the administrative resolution. He then read the following statement into the record:

To begin with, I'd like to thank everyone for being here tonight, as well as for sharing your thoughts and opinions on this matter over the course of the last few weeks. Filling the room is the Constitution at work. Exercising your God-given right to freedom of speech and right to petition your government for a redress of your grievances, both of which are upheld in the First Amendment to the U.S. Constitution, and which all five of us up here are sworn to uphold on your behalf. Over the last few years, I've heard from many of you; in person, over the phone, and through letters and emails, many in favor of this repeal and many against. I will say I've learned a lot on this one, but what I've learned was not what I expected at all. Being and reminding everyone here that this is a matter only affecting Talbot County employees, I expected to hear from many employees, and I did. All of our County employees that I spoke with were kind. They're hard working and fully supportive of repealing these policies. I heard from a grand total of zero County employees that requested to keep these DEI policies in place. I've unfortunately learned that many in favor of retaining these DEI-based policies, employee policies, those claiming to be tolerant and diverse and equitable and inclusive, like to spew hateful language when your obligations and ideas do not align with their political ideology. To the contrary, those in favor of repealing these policies could not have been more polite and respectful. Folks, this is simple. Disagreement does not have to equal disrespect. I've learned that mathematical results speak louder than words when it comes to the effectiveness of having these two administrative resolutions in place over of the last five years. Let's quickly look at one example. Our African American community, which census data shows Talbot County at 12.9 percent of our total population. In 2020, Talbot County's workforce was 17.5 percent

African American. Five years after implementing these policies, it is down to 15.8 percent. Mathematically, having these resolutions in place have been a failure in terms of diversity, equity, and inclusion. Talbot County has always been a great employer, and it will continue to be a great employer, with some of the hardest working individuals you've ever met working to serve you 24/7/365. The Talbot County employee handbook on page 21 memorializes Talbot County as an equal opportunity employer, both in principle and in fact. Our ADA, anti-discrimination, and anti-harassment practices are all covered, and all decisions are based on individual qualifications without regard to race, creed, sex, or national origin. The same format is already afforded every citizen in Talbot County found in Section 102 of the Talbot County Charter. Folks, the Constitution and its amendments are not political tools. It is not there just for some Americans and not others. It is not there to be a weaponized tool. It is a living, breathing document, enshrining the rights and freedoms to all Americans by our creator, Almighty God himself. I personally ran a campaign for this role based upon what I call the five Fs; faith, family, freedom, fiscal responsibility, and fighting for you. This is fiscal responsibility and fighting for you at its core, protecting the millions of dollars both in operational and capital form that Talbot County receives from the federal government every year. Politically motivated DEI statements, such as the two currently affecting our workforce, are crumbling all over. In the federal government, with President Trump's Executive Order on January 20th, in schools and universities, looking at the 2023 Supreme Court ruling in Students for Fair Admissions versus Harvard. And, just at the end of last week, the American Bar Association's section of legal education and admissions suspending their DEI requirement. And I quote, "over fears of litigation risk and potential violations of the law". I'm guessing that the lawyers who grant the privilege for new lawyers to practice law understand a thing or two about the 14th Amendment. Just a hunch. It's time we, as Talbot County, the employer, stop letting a politicized DEI product get in the way of true and real unity that is displayed daily in all of Talbot County. The type of unity we all see in Talbot Day, a day that all five Council members of this Council adopted, which glorifies God and celebrates, and I repeat all, Talbot County citizens. It's the type of unity that we see in our churches, our schools, our workplaces, and our volunteer organizations. The type of unity that even those with differing opinions should treat others with. And most importantly, the type of unity that Jesus commanded in Matthew 22 verse 39 – love your neighbor as yourself. I'll end with a closing paragraph from my open letter on February 11th. Talbot County is a great county. It is known for history, culture, and natural beauty, just to name a few of its attributes. We are also known for our low taxes and deservedly recognized for our financial stewardship. With the economic and inflationary pressures Talbot County citizens have had to endure in recent years, I want to do my part and ensure Talbot County residents know that their tax dollars are well represented locally and fiercely fought for nationally. Thank you again for everyone being here. And I respectfully ask for a "yes" vote from my fellow Council members on this administrative resolution today.

Council discussion ensued. Ms. Haythe asked for Mr. Stepp's consideration to table the administrative resolution until the legal process has played out with regard to President Trump's Executive Order and so the Council can obtain information as to how the County may be required to move forward as it relates to federal funding. Mr. Stepp made a motion to table the administrative resolution, and the motion was seconded by Ms. Haythe. The Council tabled the administrative resolution by voting 3-2 as follows:

Bryce Yelton, Assistant Planning Officer, stated that the Planning Commission, at its meeting on Wednesday, February 5, 2025, found Resolution No. 366 to be consistent with the 2016 County Comprehensive Plan by a vote of 4-0. Prior to the public hearing, Ray Clarke, County Engineer, stated that the Public Works Advisory Board at its meeting on Thursday, January 16, 2025, reviewed Resolution No. 367, as well as a map which identified similar parcels that would need to reviewed prior to extension of sewer; the Board had requested the map at their December 19, 2024, meeting in order to address some of their concerns. Following discussion, the Public Works Advisory Board voted 4-0-1 to recommend that the Council adopt Resolution No. 367. Bryce Yelton, Assistant Planning Officer, stated that the Planning Commission, at its meeting on Wednesday, January 8, 2025, voted to table the resolution until after the additional information had been received and reviewed by the Public Works Advisory Board and the Board had made a recommendation to the Council. Mr. Yelton stated that the Planning Commission reviewed the information at its meeting on Wednesday, February 5, 2025, and voted 4 - 0 that Resolution No. 367 was consistent with the 2016 County Comprehensive Plan. Members of the public were afforded an opportunity to comment on the legislation and Council comment ensued. The Council approved Resolution No. 367 by voting 3 - 2 as follows:

Prior to the public hearing, Ray Clarke, County Engineer, stated that the Public Works Advisory Board, at its meeting on Thursday, January 16, 2025, reviewed Resolution No. 368 and requested additional information from the Town of Trappe regarding the number of equivalent dwelling units (EDUs) being requested for the subject parcel which is zoned light commercial; the Town of Trappe had advised that one (1) EDU is being requested at the present time. Mr. Clarke stated that the Public Works Advisory Board voted 4-0- 1 to recommend that the Council approve the resolution. Bryce Yelton, Assistant Planning Officer, stated that the Planning Commission had initially reviewed the resolution at their Wednesday, January 8, 2025, meeting and voted to table the resolution until additional information had been received as requested by the Public Works Advisory Board. He stated that following review of the additional information at their Wednesday, February 5, 2025, meeting, the Commission had vote 4-0 that Resolution No. 368 was consistent with the 2016 County Comprehensive Plan. Council discussion ensued with Mr. Clarke and Mr. Yelton as to how the County could ensure that it is notified, should the owner of the parcels, which are within the municipal boundaries of the Town of Trappe, wish to increase the number of EDUs on the property. Mr. Clarke suggested Council might want to consider an annual municipal review with the towns: Council discussion again ensued. Upon motion by Mr. Lesher, seconded by Ms. Mielke. the Council voted to table Resolution No. 368 by voting 5-0 as follows:

Upon motion by Mr. Lesher, seconded by Ms. Haythe, Bill No. 1583 was brought to third reader by a vote of 5 - 0 as follows:

Ms. Haythe requested that County Attorney, Patrick Thomas, provide his legal opinion as to whether the Council could vote on the administrative resolution following public comment. Mr. Thomas stated that the matter could not be brought forward for vote during the current meeting as it had been tabled.

Members of the public were afforded an opportunity to comment on matters of interest to them.

Following public comments, Ms. Haythe made a motion which was seconded by Ms. Mielke, to suspend the Council's Rules of Procedure in order to vote on the tabled administrative resolution.
