A RESOLUTION TO AMEND THE TALBOT COUNTY COMPREHENSIVE WATER AND SEWER PLAN ("CWSP") TO CREATE A NEW SEWER SERVICE AREA COMPRISED OF CERTAIN PARCELS OF LAND IN THE VILLAGES OF BOZMAN AND NEAVITT DESIGNATED AS "TIER III-B" IN THE 2016 TALBOT COUNTY COMPREHENSIVE PLAN ("COMPREHENSIVE PLAN") AND CERTAIN ADDITIONAL PARCELS OF LAND DESIGNATED AS "TIER III-C" AND "TIER IV" IN THE COMPREHENSIVE PLAN (COLLECTIVELY, THE "ELIGIBLE PROPERTIES"); TO CLASSIFY AND MAP THE ELIGIBLE PROPERTIES AS "S-1" IMMEDIATE PRIORITY STATUS; TO APPROVE A CAPITAL PROJECT TO EXTEND SANITARY SEWER SERVICE FROM THE REGION II WASTEWATER TREATMENT PLANT IN ST. MICHAELS TO SERVE THE ELIGIBLE PROPERTIES; TO PURSUE GRANT FUNDING AND LOW-INTEREST LOANS TO FUND THE PROJECT; TO REQUIRE OWNERS OF THE ELIGIBLE PROPERTIES TO PAY CONNECTION AND SERVICE CHARGES, AS ESTABLISHED FROM TIME TO TIME, AND TO CONVEY EASEMENTS TO THE COUNTY FOR ACCESS, MAINTENANCE, AND REPAIR OF INDIVIDUAL SYSTEMS; AND TO ESTABLISH ADDITIONAL TERMS AND CONDITIONS APPLICABLE TO THE EXTENSION OF SEWER TO THE ELIGIBLE PROPERTIES

A RESOLUTION TO AMEND THE TALBOT COUNTY COMPREHENSIVE WATER AND SEWER PLAN (“CWSP”) TO CREATE A NEW SEWER SERVICE AREA COMPRISED OF CERTAIN PARCELS OF LAND IN THE VILLAGES OF BOZMAN AND NEAVITT DESIGNATED AS “TIER III-B” IN THE 2016 TALBOT COUNTY COMPREHENSIVE PLAN (“COMPREHENSIVE PLAN”) AND CERTAIN ADDITIONAL PARCELS OF LAND DESIGNATED AS “TIER III-C” AND “TIER IV” IN THE COMPREHENSIVE PLAN (COLLECTIVELY, THE “ELIGIBLE PROPERTIES”); TO CLASSIFY AND MAP THE ELIGIBLE PROPERTIES AS “S-1” IMMEDIATE PRIORITY STATUS; TO APPROVE A CAPITAL PROJECT TO EXTEND SANITARY SEWER SERVICE FROM THE REGION II WASTEWATER TREATMENT PLANT IN ST. MICHAELS TO SERVE THE ELIGIBLE PROPERTIES; TO PURSUE GRANT FUNDING AND LOW-INTEREST LOANS TO FUND THE PROJECT; TO REQUIRE OWNERS OF THE ELIGIBLE PROPERTIES TO PAY CONNECTION AND SERVICE CHARGES, AS ESTABLISHED FROM TIME TO TIME, AND TO CONVEY EASEMENTS TO THE COUNTY FOR ACCESS, MAINTENANCE, AND REPAIR OF INDIVIDUAL SYSTEMS; AND TO ESTABLISH ADDITIONAL TERMS AND CONDITIONS APPLICABLE TO THE EXTENSION OF SEWER TO THE ELIGIBLE PROPERTIES

WHEREAS, there are 22 historic rural villages in Talbot County (the “**County**”), many of which, including the villages of Bozman and Neavitt, are located in the Western part of the County in close proximity to the Chesapeake Bay and its tributaries; and,

WHEREAS, early development patterns in Bozman and Neavitt resulted in small lot sizes, typically less than one acre, improved with residential dwellings, community buildings, and small water-oriented commercial enterprises. Due to poor soil quality in the Western part of the County, small lot sizes, and a high groundwater table, many individual on-site sewage disposal systems in the Western villages today are considered failing systems by the County Health Department or substandard due to groundwater penetration; and,

WHEREAS, the failing and substandard systems in the Western part of the County, including those in Bozman and Neavitt, pose, or will pose, a threat to public health and welfare. In addition, property owners experience economic hardship due to regulatory constraints on expanding, enlarging, or modifying residential structures served by such systems, and have difficulty selling their properties. The County has addressed failing systems in other Western villages, namely Royal Oak, Newcomb, Bellevue, Unionville, Tunis Mills, and Copperville, through the extension of public sewer from the County’s Region II Wastewater Treatment Plant in St. Michaels, Maryland (the “**Region II Plant**”); and,

WHEREAS, the 2016 Talbot County Comprehensive Plan (the “**Comprehensive Plan**”) proposes to address the septic system problem through the extension of public sewer. The Comprehensive Plan identifies the Western villages as “Water Quality Strategy Areas” and recognizes that connecting individual systems to existing wastewater treatment facilities, such as the Region II Plant, is the most practical approach for correcting the problem. See Comprehensive Plan, Chapter 2 (Land Use Plan) at p. 2-11. The Comprehensive Plan further provides:

The [Talbot County] groundwater protection plan has designated most areas to the west of U.S. Route 50 as susceptible to sub-surface system failures because of high water tables, low elevations, and soils with low permeability. Communities in this area are impacted by failing septic systems, groundwater infiltration or concentrations of small lots on poorly drained soils; the communities include the Villages of Williamsburg, Sherwood, Wittman, McDaniel, Bozman, Neavitt, Claiborne, Fairbank and Bar Neck. The County will work to revise sewer connection and allocation policies to concentrate available capacity on addressing existing failing or polluting septic systems in villages Plans to extend sewer service to these areas have been drafted while funding is being pursued. Connecting communities to effective wastewater treatment plants will help achieve the County's water quality improvement and environmental health objectives.

See Comprehensive Plan, Chapter 6 (Natural Resources Element) at p. 6-13. Policy 6.21 states:

The County shall work to provide sewer service to western villages, communities and subdivisions mapped as Tier III-B and III-C for the purpose of protecting the health and safety of its citizens through improvements in water quality. This extension of sewer service is not intended for the purpose of supporting new development outside the boundaries of Tier III-B and III-C.

Id. at p. 6-18.

WHEREAS, the County adopted the Tier Maps referred to above pursuant to the *Sustainable Growth and Agricultural Preservation Act of 2012* (Senate Bill 236). Certain parcels of land in the villages of Bozman and Neavitt are mapped "Tier III-B Water Quality Strategy Areas", characterized as areas that may have public sewerage to address water quality and are planned for infill, redevelopment and limited new development only; and,

WHEREAS, certain parcels of land located along the proposed sewer line between the Region II Plant and the villages of Bozman and Neavitt are mapped "Tier III-C Areas of Limited Sewer Service", characterized as existing developed subdivisions in environmentally sensitive areas currently served by septic systems that where feasibly and reasonably practical, may be served by public sewer from the Region II Plant and where new development is limited to infill and redevelopment on existing lots within developed subdivisions; and,

WHEREAS, it is the intention of the Council that the inclusion of Tier IV parcels in this new sewer service area will not increase the amount of development or density allowed by law; and

WHEREAS, due to sewer service area mapping and connection requirements in State law and the Talbot County Code ("Code"), viz. Environment Article §§ 9-647 (b) and 9-661 (a) (1) and Code § 148-4, certain abutting parcels of land mapped "Tier IV" in the Comprehensive Plan must be included in the service area if sewer is to be extended to the Tier III-B and Tier III-C parcels. It is also feasible to connect a small number of non-abutting "Tier IV" parcels that are surrounded by Tier III-B, Tier III-C, and abutting Tier IV parcels. The Comprehensive Plan

describes “Tier IV” areas as “Mapped Resource Protection Areas” that are “designated for limited development in the County Comprehensive Plan and Zoning Ordinance” and “identified for preservation under applicable state programs and regulations.” *See* Comprehensive Plan, Chapter 2 (Land Use Plan), at p. 2-23; and,

WHEREAS, the Tier III-B parcels lie wholly within existing Rural Village Priority Funding Areas (“PFA”) while the Tier III-C and Tier IV parcels do not lie within any PFA category. In connection with the proposed sewer extension, the County will seek a PFA exemption from the State of Maryland to authorize the use of State funds to extend sewer to the Tier III-C and limited Tier IV parcels; and,

WHEREAS, the County Engineer has conducted a study to assess the feasibility, both financially and in terms of engineering, of extending public sewer from the Region II Plant to Bozman, Neavitt, and the Tier III-C Parcels and limited Tier IV parcels; and,

WHEREAS, subject to the availability of grant funds and low-interest loans, it is feasible and reasonably practical to serve Bozman, Neavitt, the Tier III-C, and limited Tier IV parcels with public sewer from the Region II Plant; and,

WHEREAS, section 9-501 *et seq.* of the Environment Article, Md. Code Ann., requires the County to develop and maintain a Comprehensive Water and Sewer Plan (the “**Plan**” or “**CWSP**”); and,

WHEREAS, the County desires to amend the CWSP to facilitate the extension of public sewer to Bozman, Neavitt, the Tier III-C parcels, and limited Tier IV parcels, and to establish additional terms and conditions governing the proposed sewer extension.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNTY COUNCIL OF TALBOT COUNTY, MARYLAND, that the Talbot County Comprehensive Water and Sewer Plan shall be and is hereby amended as follows:

SECTIN ONE: The above recitals are incorporated as if fully set forth herein.

SECTION TWO: Upon introduction of this Resolution, a public hearing will be scheduled and advertised in a newspaper of general circulation in the County advising the public of the date, time, place, and purpose of the public hearing for receipt and consideration of public comment.

SECTION THREE: The proposed amendment shall be submitted to the Talbot County Planning Commission and the Talbot County Public Works Advisory Board for review for consistency with planning programs for the area. In accordance with the requirements of Environment Article § 9-506(a)(1), Md. Code Ann., before the County Council may adopt the proposed amendment the Talbot County Planning Commission must first certify that the amendment is consistent with the County Comprehensive Plan.

SECTION FOUR: Upon conclusion of the public hearing(s), closing of the public record, receipt and consideration of certifications and recommendations from the Planning Commission and Public Works Advisory Board, the County Council will consider and act upon the proposed amendment.

SECTION FIVE: The proposed amendment to the Talbot County Comprehensive Water and Sewer Plan (“CWSP”) is as follows:

- A. New Sewer Service Area.** The CWSP is amended to create a new sewer service area, known as the “Region II – Bozman, Neavitt Sewer Service Area”, to be served by the Region II Wastewater Treatment Plant at St. Michaels (the “**Region II Plant**”), consisting of the following parcels of land:
- (i) **Bozman.** All of those 153 parcels of land in the village of Bozman mapped “Tier III-B Water Quality Strategy Areas” in the 2016 Talbot County Comprehensive Plan (the “**Comprehensive Plan**”) and which are shown on the parcel list prepared by the Talbot County Department of Public Works on November 22, 2017, attached hereto as Exhibit “A” and incorporated by reference herein.
 - (ii) **Neavitt.** All of those 164 parcels of land in the village of Neavitt mapped “Tier III-B Water Quality Strategy Areas” in the Comprehensive Plan and which are shown on the parcel list prepared by the Talbot County Department of Public Works on September 19, 2017, attached hereto as Exhibit “B” and incorporated by reference herein.
 - (iii) **Tier III-C Communities.** All of those 231 parcels of land between the Region II Plant and Neavitt, which parcels are mapped “Tier III-C” in the Comprehensive Plan and are shown on the parcel list prepared by the Talbot County Department of Public Works on November 22, 2017, attached hereto as Exhibit “C” and incorporated by reference herein.
 - (iv) **Limited Tier IV Parcels.** All of those 60 parcels of land mapped “Tier IV” in the Comprehensive Plan and shown on the parcel list prepared by the Talbot County Department of Public Works on November 22, 2017, attached hereto as Exhibit “D” and incorporated by reference herein.
 - (v) The above parcels shall be referred to collectively as the “**Eligible Properties.**”
- B. Classification and Mapping of Parcels.** The official maps of the CWSP showing sewer service areas served by the Region II Plant are amended to classify and map the Eligible Properties as “S-1” (Immediate Priority Status) as shown on the map titled “Talbot County Sewer Service Worksheet Bozman/Neavitt Area Resolution 250 Plus Abutting & Close Proximity Parcels” prepared by the Talbot County Department of Public Works on November 28, 2017, attached hereto as Exhibit “E” and incorporated by reference herein.
- C. Capital Project.** The CWSP is amended to add a new capital project to Table 24 (Talbot County Region II Sanitary District St. Michaels Capital Improvement Projects) to extend sewer service from the Region II Plant to the Eligible Properties (the “**Capital Project**”). The Capital Project includes without limitation the planning, design, and construction of a sewer line from the Region II Plant to the Eligible

Properties as described herein; construction of pump stations to complete the sewer extension; and, acquisition of real property, rights-of-ways, easements, and other interests in property as needed. The Capital Project is hereby approved subject to the terms and conditions set forth below and which are incorporated by reference herein, as approved, adopted, or amended by the County from time to time.

- D. Capacity and Flow Allocation.** The CWSP is amended to add a description of the proposed sewer extension and to amend Table 5 (Revised Allocation of Capacity for 660,000 gallons per day) with estimated future sewerage flows for the Region II – Bozman, Neavitt Sewer Service Area of 91,200 gallons per day, as shown on Exhibit “F” attached hereto and incorporated by reference herein.

SECTION SIX: Connections to the proposed sewer line shall be subject to the following terms and conditions:

- A. Limited Access Line.** No property or parcel other than an Eligible Properties shall be entitled to connect to the proposed sewer line unless the proposed connection satisfies the criteria for connecting to the sewer line from property outside the sewer service area set forth in Resolution 175 (the “**Carroll’s Market Policy**”).
- B. Single Connection per Tier Map Parcel.** Eligible Properties shall be entitled to a single sewer connection available to each parcel based on the official Tier maps for Talbot County as set forth in the Comprehensive Plan, except as provided in Sections 6 C. and D., below.
- C. Tier III-B Infill, Redevelopment, and Limited New Development.** Subject to available capacity at the Region II Plant, additional sewer connections to Tier III-B parcels located in the villages of Bozman and Neavitt and included in the parcel lists attached hereto as Exhibits “A” and “B” shall be available for residential infill, redevelopment, and limited new development occurring after the adoption of this Resolution in accordance with the Chapter 190 of the Talbot County Code, as amended from time to time, and applicable State laws.
- D. Tier III-C and Tier IV Parcels.** The Tier III-C and Tier IV parcels included in the parcel list attached hereto as Exhibits “C” and “D” shall only be eligible for a single sewer connection per tier map parcel and shall not be eligible for additional sewer connections using Federal, State, or County funds. Additional connections within the mapped “S-1” areas are subject to available capacity at the Region II Plant and all applicable land use restrictions, and the entire cost associated with any such connections shall be born exclusively by the property owner. Such costs shall include without limitation a fee in the amount of the Sewer Extension Charges levied against similar properties in the service area calculated without the assistance of Federal, State, or County funds.
- E. Connection Required; Timing.** All of the improved Eligible Properties shall connect to the proposed sewer line at the earlier of the following: (i) the issuance of a certificate of completion or occupancy for any expansion, addition, or reconstruction of the

existing residential dwelling for which a building permit is required whose cost exceeds 50% of the structure's present assessed value for property tax purposes, as determined by the Talbot County Planning Officer; (ii) failure of the existing on-site sewage disposal system as determined by the Talbot County Office of Environmental Health; or, (iii) upon transfer of the property as part of an arms-length sale. For unimproved Eligible Properties, connection to the sewer system shall occur when the owner makes any improvement requiring sewage disposal.

- F. Sewer Extension and Connection Charges.** For the purpose of providing funds for the payment of any debt incurred by the County to finance the sewer extension, at the time that the County begins to make payment on such debt, there shall be fixed and levied on all of the Eligible Properties, the estimated cost of the sewerage system extension exclusive of the item in Talbot County Code § 148-5 A. (5) (d) and a capital connection charge (collectively the "Sewer Extension Charges."). In the discretion of the Talbot County Finance Officer, the Sewer Extension Charges levied may be paid annually in accordance with Talbot County Code § 148-21 and/or payment of the levied charges may be delayed until the time of connection, or paid as required by any grants or loans associated with the project. Each owner of an Eligible Property shall be required to complete a public works agreement as described in Talbot County Code § 148-2. Property owners shall also be responsible for payment to the Region II Sanitary Sewer District (the "**District**") of all sewer service connection charges, sewer service charges, and other charges, tariffs, assessments, levies, or taxes lawfully imposed from time to time (collectively "**Sewer Charges**"). Unpaid Sewer Extension Charges and Sewer Charges shall be a lien on the real property collectible in the same manner and to the same extent as unpaid real property taxes.
- G. Grant and Loan Conditions.** In addition to the terms and conditions above, connections to the proposed sewer line shall be subject to any lawful terms and conditions imposed by the Federal government or the State of Maryland as a condition of any grant or loan the County or a property owner obtains to finance or facilitate the extension of sewer as provided herein. Grant funding from the State of Maryland for capital costs up to \$20,000 may be available to eligible property owners. The amount, if any, of grant funding available for each property to connect remains to be determined under applicable grant and other criteria, including without limitation, the cost to connect as to each eligible property and the property owner's individual household income.
- H. No County Liability to Any Property Owner.** The County shall have no obligation to any property owner other than to apply for and administer such grant or grants as have been or may be awarded, and no property owner shall have any recourse against the County or its officers or agents concerning the award or lack of any award of any grant, eligibility or lack of eligibility for complete or partial grant funding for any cost, including without limitation the cost to connect any eligible property to the proposed sewer line.

- I. County Ownership of Infrastructure.** As a condition of connecting to the proposed sewer line, each owner of any Eligible Property shall, at no cost to the County or to the District, grant and convey to the County for the use and benefit of the District all septic tanks, pumps, lines, couplings, connections, appurtenances, fixtures, and structures (the “**Infrastructure**”) used or required to provide sewer service to the eligible property in accordance with all requirements of applicable building or construction codes, rules, requirements, and regulations. The County Engineer shall evaluate the condition of the existing Infrastructure for suitability for use within the Septic Tank Effluent Pump Station. If the septic tank is not in satisfactory condition, the owner shall replace the tank at their cost as a condition of connecting to the proposed sewer line. The property owners shall continue to own, and to remain responsible for installation, repair, construction, and maintenance of all lines and equipment from the structure to be served by the connection to the septic tank, including the connection to the tank. The County shall own and maintain the Infrastructure from and including the existing or owner-replaced septic tank to the proposed sewer line.
- J. Easements.** As a condition of connecting to the proposed sewer line, owners of Eligible Properties shall, at no cost to the County or to the District, grant and convey a perpetual easement to the County authorizing the County, its agents and employees, to enter on, over, under, and through the property for purposes of inspecting, installing, maintaining, and repairing the Infrastructure, in form and content acceptable to the County. The easement shall be recorded among the land records as a condition precedent of connecting the property to the proposed sewer line and shall run with and bind the land.
- K. Amendment.** The County may from time to time amend the above terms, conditions, and policies; establish additional terms, conditions, and policies; and, delete or eliminate terms, conditions, and policies applicable to the Region II – Bozman, Neavitt Sewer Service Area.

SECTION SEVEN: The County intends to rely upon grant funding and low-interest loans to finance the Capital Project subject to the following:

- A. Authority to Pursue Funding.** The County and the District are authorized to pursue and apply for grant funding and low-interest loans from the State of Maryland the Federal government to finance the extension of public sewer to the Eligible Properties.
- B. Council to Approve Acceptance of Funds.** The County Council reserves the right to approve acceptance of any grant funds and low-interest loans that may be awarded or granted to the County or the District.
- C. Receipt of Sufficient Funds.** The County’s decision to extend sewer is expressly conditioned on obtaining sufficient grant funds and/or low-interest loans, to be determined in the County’s sole discretion, to finance the sewer extension. If the County does not receive adequate funding for the project through a combination of grants and/or low-interest loans, the County reserves the right not to proceed with the project. Neither the County nor the District shall have any liability or financial

obligation for any expense in connection with the project. All costs and expenses incurred to construct the project shall be paid using grant funds, low-interest loans, and/or shall be paid by property owners from the Eligible Properties.

SECTION EIGHT: Adoption of this Resolution shall not excuse, modify or supersede requirements for current and ongoing compliance with all applicable Federal, State, and local statutes, ordinances, or regulations including the issuance of all required permits and approvals for connection of Eligible Properties to the proposed sewer line.

BE IT FURTHER RESOLVED, that this Resolution shall take effect immediately upon the date of its passage.

BE IT FURTHER RESOLVED, that the title is determined to be a fair summary of this Resolution; and further, that the title is not a substantive part of this Resolution. If the Resolution is amended, the title may be administratively revised if required to conform the title to the content of the Resolution as finally enacted; and,

BE IT FURTHER RESOLVED, that if any provision of this Resolution or the application thereof to any person or circumstance is held invalid for any reason in a court of competent jurisdiction, the invalidity does not affect other provisions or any other application of this Resolution which can be given effect without the invalid provision or application, and for this purpose the provisions of this Resolution are declared severable; and,

BE IT FURTHER RESOLVED, the Talbot County Office of Law, in consultation with and subject to the approval of the County Manager, shall make non-substantive corrections to codification, style, capitalization, punctuation, grammar, spelling, and any internal or external reference or citation to the Code that is incorrect or obsolete, with no further action required by the County Council. All such corrections shall be adequately referenced and described in an editor's note following the section affected.

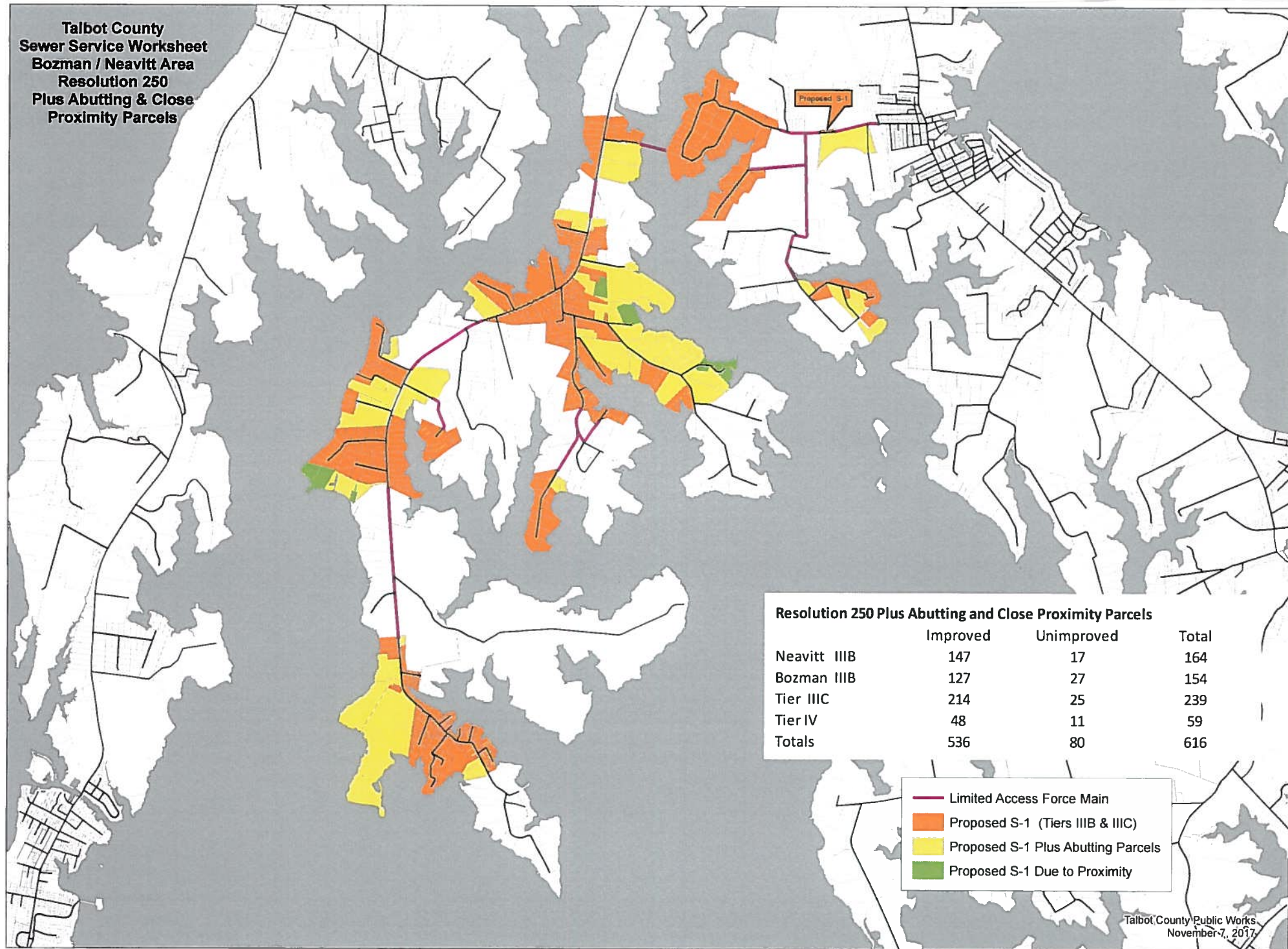

Bozman, Neavitt Sewer Service Area

The villages of Bozman and Neavitt are located in the Western portion of the County where, due to poor soil qualities, small lot sizes, and high water tables, there are many failing and substandard on-site sewage disposal systems. The Department of Public Works has conducted a feasibility study to explore extending sewer service from the Region II Wastewater Treatment Plant in St. Michaels to 544 parcels of land in the villages of Bozman and Neavitt mapped “Tier III-B” and in communities mapped “Tier III-C” in the 2016 Talbot County Comprehensive Plan. The Department of Public Works has also evaluated the feasibility of connecting a limited selection of “Tier IV” parcels, 59 in total, that abut the way in which the sewer line will be laid or are surrounded by eligible Tier III-B, Tier III-C, and abutting Tier IV parcels. This area shall be known as the “Region II – Bozman, Neavitt Sewer Service Area.” The Department of Public Works has calculated the expected future flows for this sewer service area based on 125 gallons per day per dwelling unit. Consistent with EPA and MDE guidelines, a safety factor of 20% is used to estimate the total expected future flows to the Region II – Bozman Neavitt Sewer Service Area, calculated as follows:

Estimated Total Flow (Q) = Existing Flow (Q_{existing}) + Future Flows (Q_{future}) + 20% Safety Factor

~~81,600~~ 90,450 = 0 + ~~68,000~~ 75,375 + ~~13,600~~ 15,075

The total estimated future flows of ~~81,600~~ 90,450 gallons per day shall be taken from the current sewer capacity allocation for the Town of St. Michaels as shown in Table 5, below. The

County intends to pursue grant funding and low-interest loans from the State of Maryland and/or the Federal government to finance the sewer extension project.
